DISS243 Contemporary East Asia: Understanding the Chinese Economy and Market College of International Studies (CIS), Korea University Summer Term, 2022 (Mon - Thurs, 9 am - 11:50 am)

COURSE DESCRIPTION

China has experienced a gradual transition from a centrally-planned to a market economy. This transition has companied with impressive economic development and significant integration into the global economy. The resultant business environment is unconventional and consequently doing business in China is challenging. Even China is currently locked in an escalating trade war with the US.

This course focuses on market transition, particular emphasis on the major domestic and international issues that have affected the development and growth of China's economy. This includes China's traditional economic system, economic reforms, rebalance of its economy, the Belt and Road initiative, labour market, state-owned enterprises, non-state sectors, and financial sector. It also covers the key issues of the China-US trade war and the key impacts of these issues on the China specific business environment.

Each part of the course will provide you with institutional background and process of China's economic reform and its implication for key management practice. By doing so, this course should help you to integrate what you learn from other courses in a Chinese context.
